



All Star Futurity Auction Rules

Revised 12/14

I. Auction Income

- a) Auction monies are dispersed as follows: 50 percent of total auction proceeds would be divided between all the Futurity Classes that make in a given year (12, with the addition of four sport horse classes.) The remaining 50 percent of auction proceeds would be divided on a prorated basis per horse among all the entries at the Futurity show. Income from the Stallion Auction is divided as follows: (1) 10% to promotion and awards, (2) the remainder to be divided per the above among all Futurity classes with at least one entry. (This does not include Championship classes.)
- b) Nomination income will go to the particular division in which the nominations were made. For example: all purebred nomination money will be divided equally in the two weanling classes.
- c) Re-nomination income goes toward the class for which the re-nominations were for.
- d) Other income such as entry fees is applied toward the class in which the entry was made.

II. Qualifications Required Of Arabian and Non-Arabian Stallions Seeking Nomination into The All Star Stallion Auction

- a) Stallions must be two years of age or older within the breeding season for which the service is sold.
- b) Arabian Stallions must be Sweepstakes Nominated Sires.
- c) Stallions that have won a Regional Top Five or better, or stallions that have sired get that have accomplished the above qualifications are eligible.
- d) Sweepstakes nominated stallions with outstanding show records will be considered on an individual basis.
- e) In order to include Junior Arabian stallions (2-5 years old) with outstanding accomplishments, the requirement for being a Breeders Sweepstakes Nominated Sire is suspended and participation allowed up to the first day of the stallion's 6th

year. After January 1st of the stallion's sixth year, he must have Breeders Sweepstakes status or be removed from the list of Auction stallions.

- f) With the addition of a Sport Horse division in the club's Futurity program, the Committee anticipates that more owners of non-Arab stallions will wish to participate. Breeders Sweepstakes status is no longer required, but the stallion's accomplishments will be considered by the Committee on a case-to-case basis.
- g) Imported stallions (which may not currently have a US show record), will be considered by the Futurity Committee for approval prior to contacting owners requesting donations. A 2/3 majority vote of committee members is required for inclusion of the colt in the Auction.
- h) Non-Arabian Sires who have exhibited exceptional quality, sired champion get, or have outstanding show records will be considered.
- i) Photos of stallions used on the website must first be approved by the Futurity Chairman. Before club members invite new auction stallions, to join our stallion roster, they must first be approved by the Futurity Committee. Our emphasis is on QUALITY, not Quantity. Nominations must be given to the Futurity Chairman for distribution to the Futurity Committee. Stallions that no longer meet the criteria can be reviewed by the Committee for continuation in the auction program.

III. Stallion owners, who donate, get one free mare nomination per stallion donation to be used to nominate mares prior to December 31st of the calendar year in which the breeding is sold, or in either of the following two years. This donation is transferable to a stallion owner's client, provided the mare in question is bred to the donated stallion. No replacement certificates will be issued, and original, numbered certificates must be submitted with nomination. **WCAHA membership REQUIRED at time of use of free mare nomination.** (See Futurity Rules for eligibility to nominate—Club membership requirements, etc.)

IV. 10% of Auction funds is allocated for promotion and awards.

V. Copy and photos for submission to publications or website relating to the Futurity must be approved by the Futurity and Promotions Chairperson.

VI. Bidding begins at one half the advertised stud fee or the minimum fee posted. No extended auction will take place.

VII. Post Entries: No post entries will be accepted for Futurity entries. **VIII.**
